Willie D. Wise, Clerk, and Deputy Sheriff Ronnie Stone were present and acting.

The meeting was called to order by the Deputy Sheriff followed with prayer by Commissioner Whitfield.

Bids were opened as advertised for paving of 19th Street and are as follows:

A motion was made by Commissioner Bailey, seconded by Commissioner Varnum and duly carried to accept the low bid from Florida Asphalt in the amount of \$29,205.95.

Mr. Jim Morgan with the Chamber of Commerce met with the Board on his achievements since he started with the Chamber.

Ms. Frankie Williams and Mr. Foster met with the Board concerning the Calhoun County Library System. Mr. Foster spoke to the Board about the possibility of a mail-a-book service for Calhoun County. After some discussion, the Board agreed to take this up at the budget hearings.

Mr. L. B. Traylor met with the Board concerning the road by his property on Chipola River and about the parking problem which was brought to the Board's attention at the previous meeting by Mrs. Vilas Pope. After some discussion, the Board agreed for the Sheriff to handle this.

Mr. Ben Gay met with the Board to see if he could get aid in helping pay a hospital bill for his son. Chairman Tatum informed Mr. Gay that the County did not have any money in the account at this time and had to turn down a request at the last Board meeting, but could help with temporary aid. A motion was made by Commissioner Bailey, seconded by Commissioner Shiver and duly carried to give temporary aid in the amount of \$48.30 to Mr. Gay.

Mr. Martin Hayes, Assistant CETA Administrator, made a report on the CETA Program in the County.

Mr. Jack Bowman met with the Board concerning one of his employees, Jim Killingsworth. Mr. Bowman stated that Mr. Killingsworth had his wife admitted to Calhoun General Hospital for sickness, and that Mrs. Killingsworth should not have been admitted at all. Mr. Bowman further stated that Mrs. Doris Traylor at the hospital refused to release Mrs. Killingsworth until some financial arrangements had been made concerning the bill, and that since Calhoun General's operation was aided by some tax money, the hospital should have terms available for payment. Mr. Bowman informed the Board that Mr. Killingsworth had borrowed the money from the Ellis Bank of Blountstown for the bill and requested the Board of County Commission to pay Mr. Killingsworth \$250.00. Chairman Tatum informed Mr. Bowman that there was not any money in this account at this time, and that the Board had refused an earlier request at the beginning of the meeting and one at the last Board meeting because of this. Mr. Ellis Melvin, County Road Superintendent, made a report on the County Road Department.

Mr. Gene Carter, Secondary Road Superintendent, made a report on the secondary roads.

A motion was made by Commissioner Bailey, seconded by Commissioner Shiver and duly carried to give temporary aid to Jim Killingsworth in the amount of \$48.30.

A motion was made by Commissioner Bailey, seconded by Commissioner Shiver and duly carried to replace one of the speed guns with the Sheriff's Department.

A motion was made by Commissioner Bailey, seconded by Commissioner Shiver and duly carried to accept a bid extention on metal drain pipe from Southern Culvert.
