BOARD OF COUNTY COMMISSION MINUTES OF SEPTEMBER 30, 1980 SPECIAL SESSION

The Board met this day in special session with the following members present, to-wit: Lloyd Tatum, Chairman, Clayton Shiver, Gene Bailey, Bobby Varnum and Donnell Whitfield.

Willie D. Wise, Clerk, was present and acting.

The meeting was called by Chairman Tatum in order to review the budget.

A motion was made by Commissioner Bailey, seconded by Commissioner Whitfield and duly carried that as of October 1, 1980, any county employee having eight years employment without a break in service is to have 3 weeks vacation.

A motion was made by Commissioner Bailey, seconded by Commissioner Shiver and duly carried to change Gene McClellan from CETA back to HUD.

A motion was made by Commissioner Whitfield, seconded by Commissioner Shiver and duly carried to give all employees under the Board an 8% annual raise effective October 1, 1980.

A motion was made by Commissioner Bailey, seconded by Commissioner Shiver and duly carried to promote Martin Hayes to CETA Director and Carlton Smith to CETA Program Coordinator and to give an 8% raise if approved by CETA.

A motion was made by Commissioner Bailey, seconded by Commissioner Shiver and duly carried to appoint Commissioner Whitfield as liason to CETA, Commissioner Shiver to HUD and Commissioner Varnum to the Six County River Committee.

A motion was made by Commissioner Shiver, seconded by Commissioner Whitfield and duly carried to pay the maintenance supervisor \$12,000.00 per year, the same as the County Road Superintendent.

A motion was made by Commissioner Bailey, seconded by Commissioner Whitfield and duly carried to move the Unemployment Service, Social Security office and Drivers License personnel to the old Food Stamp Office effective October 13, 1980..

A motion was made by Commissioner Bailey, seconded by Commissioner Whitfield and duly carried to set the loader operator's pay the same as the mechanic's pay.

A motion was made by Commissioner Whitfield, seconded by Commissioner Shiver and duly carried to pay the grader operators \$125.00 per month for using their trucks to haul fuel for the grader.

A motion was made by Commissioner Bailey, seconded by Commissioner Shiver and duly carried to adopt a resolution asking the Florida representatives and senators to introduce legislature turning control of the Dead Lakes Water Management District to the Gulf and Calhoun County Board of County Commissions. A motion was made by Commissioner Bailey, seconded by Commissioner Shiver and duly carried to adopt a resolution requesting disbursement of \$49,500.00 for cost of audits. (FOR RESOLUTION, SEE SUPPLEMENTAL MINUTE BOOK 1, PAGE 160 , SECTION C)
