

BOARD OF COUNTY COMMISSION  
MINUTES OF MARCH 17, 1981

The Board of County Commission met this day in regular session with the following members present, to-wit: Clayton Shiver, Chairman, Bobby Varnum, Donnell Whitfield, Jack Bowman and Monroe Cox.

Willie D. Wise, Clerk, and Sheriff William G. Smith were present and acting. The meeting was called to order by the Sheriff followed with prayer by Commissioner Whitfield.

Mr. Corbin Cawthorne with Florida Engineering met with the Board and discussed the road paving projects in the county. Commissioner Cox stated that on the Wrennie Moody Road he wanted it done right with the county getting the most for the money. This road is to be let in two bids.

Mr. Cawthorne stated that the right amount of asphalt was put on the Carlos Peavy Road, and that the dips were caused by "clay ball".

Mr. Jimmy Yon met with the Board concerning property markers on his land on the Marysville Road. After some discussion, Robert Nations with Florida Engineering stated that to reset this marker could run from \$2,500.00 to 3,000.00. He also stated that he had given this information to then Commissioner Gene Bailey, and he in turn told Mr. Nations to hold off on resetting the marker.

Mr. Jim Doyle, Certified Public Accountant, brought to the Board's attention the service agreement between the Chamber of Commerce and the Board of County Commission. Mr. Doyle also stated that the county's records were being kept better now than in the past.

Mr. Jack Dykes met with the Board to see what was being done on the Wrennie Moody Road.

Mr. Danny McCollum met with the Board and asked about the lights at the S. B. Atkins Park. Chairman Shiver stated that he should see Lorene Brown.

Mr. Gene McClellan, Program Coordinator, made a report to the Board on the HUD Program.

A motion was made by Commissioner Cox, seconded by Commissioner Bowman and duly carried to keep the pan to be used only for HUD or new road construction and maintenance under the 80% 5th and 6th cent gas tax.

Mr. Gene McClellan stated that the Department of Environmental Regulation had to be answered on the sanitary land fills by Thursday, March 19, 1981. A motion was made by Commissioner Whitfield, seconded by Commissioner Bowman and duly carried not to open any more garbage pits and to get in compliance with the Department of Environmental Regulation.

Mr. Ellis Melvin, County Road Superintendent, made a report to the Board on the road department.

Mr. Buddy Murphy, representing Lapeyrouse Grain Mill, asked for the Board to grade the drive to the mill. The Board agreed that no work was to be done on private property.

Commissioner Whitfield stated that he wanted to advertise on the repair of the house at the road department, and to accept bids at the Board meeting to be held April 21, 1981.

A motion was made by Commissioner Whitfield for Ellis Melvin to park his truck every night. Motion seconded by Commissioner Cox. Commissioners Whitfield and Cox voted "yes" and Commissioners Bowman, Shiver and Varnum voted "no".

Commissioner Bowman recommended that when someone wants to sign up on the HUD Program, they should see Lorene Brown in Gene McClellan's office and she will take all the information and fill out the application.





BOARD OF COUNTY COMMISSION  
MINUTES OF APRIL 7, 1981

The Board of County Commission met this day in regular session with the following members present, to-wit: Clayton Shiver, Chairman, Bobby Varnum, Jack Bowman, Monroe Cox and Donnell Whitfield.

Willie D. Wise, Clerk, Sheriff William G. Smith and Attorney Bill Corbin were present and acting. The meeting was called to order by the Sheriff followed with prayer by Commissioner Varnum.

Mr. Corbin Cawthorne with Florida Engineering presented the Board with the final report on the Altha By-pass Road.

Mr. Dewey Clemmons stated that there was a shortage of 191 tons of asphalt on the Altha road. After some discussion, Commissioner Bowman recommended that the road be cored with Mr. Clemmons present. Mr. James Rowe with Gulf Asphalt stated that the core had been made, and the road was 2-inches, and he would give an additional one (1) year warranty. The Board disagreed completely with Engineer Corbin Cawthorne's report on the road.

Mr. Gene Lampkin met with the Board concerning the garbage pick-up in the county.

A motion was made by Commissioner Whitfield, seconded by Commissioner Varnum and duly carried to pay \$250.00 to the Jackson County Hospital for Carl Shelton.

Mr. Bill McGill with C.A.P. met with the Board concerning the programs his agency was handling for this area. Mr. McGill requested the Board to adopt a resolution to send to the Governor concerning the aid to the poor.

Ms. Louise Stewart met with the Board to see if any jobs were available with the County. The Board stated that due to budget conditions, no jobs were available.

Ms. Neel with the Library met with the Board to get the names of the new Library Board members. Chairman Shiver stated they were Clarice Capps and Rita Maupin.
