

BOARD OF COUNTY COMMISSION
MINUTES OF MAY 5, 1981

The Board of County Commission met this day in regular session with the following members present, to-wit: Clayton Shiver, Chiarmman, Bobby Varnum, Donnell Whitfield, Jack Bowman and Monroe Cox.

Willie D. Wise, Clerk, Attorney Bill Corbin and Sheriff William G. Smith were present and acting.

The meeting was called to order by the Sheriff followed with prayer by Commissioner Whitfield.

Mrs. Neel with the Calhoun County Library met with the Board about the new system being installed at the library.

Mr. Dewey Clemmons met with the Board and stated that the Altha paving was completed.

Mr. Frank Stone, Property Appraiser, met with the Board and stated that the map machine in his office was worn out, and that he would need to put money in his 1981-82 budget request to pay for a new map machine.

Mr. C. J. Roberts met with the Board and presented a report on the Rehab and Weatherization Programs.

Mr. Alvin Roberts made a report to the Board on the maintenance department.

Mr. Robert Nations with Florida Engineering met with the Board and presented a set of plans for the paving of the Wrennie Moody Road.

Mr. Ellis Melvin, County Road Superintendent, made a report to the Board on the regular road department. Mr. Gene Carter, Assistant Road Superintendent, made a report to the Board on the secondary road department.

Mr. Jim Doyle, Certified Public Accountant, presented the Board with a proposal to audit the county's records for a total cost of \$29,500.00 for 1981. This was to be tabled until the next Board meeting.

Mr. Mike Maloy met with the Board concerning the store to be built at the Hugh Creek Community. After some discussion, Mr. Maloy stated that he was opposed for the County going into the grocery business. Also, he was not for the County going into any type of private enterprise. Mr. Maloy asked Chairman Shiver to poll the Board to see how many commissioners were for putting the store in. Commissioner Whitfield stated he was opposed to the store as written up in the grant. Commissioners Varnum, Cox and Shiver stated they were of the same opinion.

Mr. Carl Shelton presented the Board with a note from Dr. A. E. McQuagge stating that he could return to light duty work. The Board agreed for Mr. Shelton to return to work on Wednesday, May 6, 1981.

Attorney Bill Corbin presented the Board with a letter to Jim Appleman, State Attorney, on the tax collector's office. A motion was made by Commissioner Whitfield, seconded by Commissioner Varnum and duly carried to change the Bond on the tax collector from \$25,000.00 to \$100,000.00.

A motion was made by Commissioner Bowman, seconded by Commissioner Varnum and duly carried to adopt a resolution concerning the barges on the Apalachicola River. (FOR RESOLUTION, SEE SUPPLEMENTAL MINUTE BOOK 1, PAGES 5-6 , SECTION D)

Commissioner Cox inquired as to the opening of the canning center. After some discussion, the Board agreed that as of June 3, it would be open for shelling peas and beans only at \$.50 per hamper for Calhoun County residents and \$1.00 per hamper for out of county residents. Employees of the canning center will be from the CETA Youth Program.

The Clerk read a letter from the Altha Town Council supporting C.A.P.

The meeting was called to order by the Sheriff followed with prayer by Commissioner Shiver.
