

BOARD OF COUNTY COMMISSION
MINUTES OF SPECIAL MEETING
MAY 22, 1981

The Board of County Commission met this day in special session with the following members present, to-wit: Clayton Shiver, Chairman, Bobby Varnum, Jack Bowman, Monroe Cox and Donnell Whitfield.

The meeting was called to order by Willie D. Wise, Clerk.

Bids on the county's insurance were discussed and are as follows:

A motion was made by Commissioner Whitfield, seconded by Commissioner Varnum and duly carried to accept the lowest and best bid from Midyette Moor Insurance Company.

The bids on the collection of garbage were discussed, and the Board agreed to investigate all bidders.

A motion was made by Commissioner Bowman, seconded by Commissioner Whitfield and duly carried to advertise to consider passing an ordinance on garbage collection on the advice of Bill Corbin, County Attorney.

County Attorney Bill Corbin made a report to the Board on the DER cases concerning landfill sites and the John Redd Road.

County Judge Jim Godwin met with the Board to consider raising court cost. After some discussion, Judge Godwin stated that he was not for raising the cost which is now \$27.00, but would abide by the Board's decision.

A motion was made by Commissioner Whitfield, seconded by Commissioner Cox and duly carried to adopt an ordinance to set the court cost at an increase of \$10.00.

Judge Godwin stated that if the State or Federal Government was going to set the rules and regulations for operating the County, they should have to pay for it.

Donald Klien requested a change in the procedures in the qualifications of hiring of CETA personnel. Commissioner Whitfield stated he gave permission for Mr. Klien to change the procedures. Commissioner Cox asked why the Board was not informed of the changes. Commissioner Bowman asked did Commissioner Whitfield sign a letter to make the changes. Commissioner Whitfield said he did sign the letter. Commissioners Cox and Bowman feel the Board should be aware of any changes being made regarding CETA. Commissioner Whitfield said any changes to be made will come before the Board. Commissioner Cox stated he was in favor of stopping the letter and bringing the subject before the Board. Commissioner Whitfield stated that the requirements had not been changed for the director. The change was made on the counselor-coordinator from a 4-year college degree to a 2-year degree or 5-years experience. Commissioner Bowman stated that he wanted the letter rescinded that Mr. Klien sent to Tallahassee. Commissioner Whitfield stated that any hiring in an administrative position will be approved by the Board. Commissioners Cox and Bowman agreed to rescind the letter and Commissioners Whitfield, Shiver and Varnum agreed to leave it as it was.

There being no further business, the Board did then adjourn.
