Ms. Alice Daniels with CAP met with the Board to see about getting some assistance in paying some bills for Terry Burke (\$20.33) and Russell Bramblett (\$48.30). The Board agreed to pay the above amounts.

A motion was made by Commissioner Whitfield, seconded by Commissioner Shiver and duly carried to adopt a resolution concerning hazardous waste. (FOR RESOLUTION, SEE SUPPLEMENTAL MINUTE BOOK 1, PAGE 26, SECTION D).

The public hearing was held at 5:00 P.M. on the petition to close a road going thru Olan Griffin's property. After some discussion, a motion was made by Commissioner Bowman, seconded by Commissioner Cox and duly carried to adopt a resolution to close the road. (FOR RESOLUTION, SEE SUPPLEMENTAL MINUTE BOOK 1, PAGES 27-28, SECTION D)

After some discussion, the Board agreed to charge \$9.00 per house (minimum of 2 hours) per field and \$50.00 per night for tournaments. Commissioner Bowman stated he was not in favor of charging \$9.00 per hour for the Little League, but \$6.00 per hour. Commissioners Cox, Whitfield, Shiver and Varnum voted \$7.00 for the Little League fields. Commissioner Bowman voted "no". The Board agreed on \$6.10 per hour on the tennis courts as it was decided it would take this in order to offset the light bill.

Mr. Riley Adams met with the Board concerning a road off Hwy. 73 North. Commissioner Bowman stated that he thought the matter was settled.


Ms. Jean Wood had submitted an application for employment at the canning center. The Board agreed to hire Ms. Wood and Ms. Estelle Hood to operate the canning center.


Commissioner Bowman recommended the Board appoint Clerk Willie D. Wise to be in charge of the Weatherization Grants. All Board members agreed.

BOARD OF COUNTY COMMISSION
MINUTES OF SPECIAL MEETING
MARCH 10, 1982

The Board of County Commission met this day in special session with the following members present, to-wit: Bobby Varnum, Chairman, Donnell Whitfield, Jack Bowman, Monroe Cox and Clayton Shiver.

Willie D. Wise, Clerk, and Attorney Bill Corbin were present and acting.

The meeting was called to order by Chairman Varnum.

Chairman Varnum stated the purpose of the meeting was to discuss Hwy. 274 at the request of William D. Baxter, owner of Baxter's Asphalt Company.

Mr. Baxter inquired as to the percentage of completion on Hwy. 274. Robert Nation, County Engineer, stated it was 90% complete. Mr. Baxter showed the Board some core samples of the road and also stated the asphalt was not on the road as the bid specified. Mr. Baxter stated the cores were short, and that out of seven (7), only one (1) core was up to par.

After discussion by the Board members, James Rowe with Gulf Asphalt and Robert Nations with Florida Engineering Company, Commissioner Cox made a motion that Mr. Baxter, Gulf Asphalt, the Board of County Commission and the road superintendent, Fernwood Bailey, redrill the road to determine if the road did meet the specifications. Motion seconded by Commissioner Bowman and duly carried.

James Rowe with Gulf Asphalt made a statement to the Board and stated that the road was to bid specifications.

Robert Nations also stated the road was built to bid specifications.

Mr. Baxter stated he was ready to go to court to see the taxpayers were protected on the job.

A motion was made by Commissioner Bowman, seconded by Commissioner Shiver and duly carried for Hwy. 274 to be recored by specifications of the Department of Transportation.

Three applications were presented to the Board by Clerk Willie D. Wise to be reviewed for the position of Assistant County Agent with the Extension Service.

Each application was reviewed and discussed by the Board members.

A motion was made by Commissioner Bowman, seconded by Commissioner Shiver and duly carried to hire Wayne Clarence Martin as the assistant county agent effective April 1, 1982.

Logan Barbee, County Agent, stated he was pleased with the three applicants that were presented.

A motion was made by Commissioner Shiver, seconded by Commissioner Bowman and duly carried to give each district 20% of the Weatherization Grant.

A motion was made by Commissioner Shiver, seconded by Commissioner Bowman and duly carried to change Gene McClellan from Program Coordinator to HUD Director.

There being no further business, the Board did then adjourn.

MINUTES OF MARCH 16, 1982

The Board of County Commission met this day in regular session with the following members present, to-wit: Donnell Whitfield, Monroe Cox, Clayton Shiver, and Jack Bowman.

Willie D. Wise, Clerk, Sheriff William G. Smith and Bill Corbin, County Attorney, were present and acting. The meeting was called to order by Sheriff Smith followed with prayer by Commissioner Whitfield.

Mr. Blon Carter met with the Board to see if he could get some work done on his house thru the HUD Program. Vice-chairman Whitfield explained to Mr. Carter, and presented a letter from HUD stating that if any money had been spent on a house out of HUD funds in the past that no more money could be spent. Commissioner Shiver stated that if any way was possible he would like to see the house fixed.

Mrs. Vonnie Duke, Tax Collector, met with the Board for permission to pay a tax certificate to Jim Naiper. A motion was made by Commissioner Bowman, seconded by Commissioner Shiver and duly carried to pay the \$170.60.

Mr. Bill Atkins with Florida Engineering Company met with the Board about final payment on Highway 274. After some discussion, Vice-chairman Whitfield recommended that this be tabled until all parties concerned could get together.

Mr. Pack Bowden met with the Board concerning preserving some property on the Chipola River for a state park. A motion was made by Commissioner Shiver to adopt a resolution supporting the Chipola River site (Look and Tremble). Motion seconded by Commissioner Bowman and duly carried. Ms. Cindy L. Free had an application presented for employment.

Commissioner Bowman made a report to the Board on the 1¢ sales tax. Commissioner Bowman had spent a day in Tallahassee for meetings and stated Calhoun County would receive approximately \$185,000.00 if it passed the Senate as it was.

Commissioner Cox stated that Billy Roberson with Florida Forest Service would have the two (2) fire trucks by the last of June.
