The Board of County Commission met this day in regular session with the following members present, to-wit: Bobby Varnum, Chairman, Donnell Whitfield, Clayton Shiver, Jack Bowman and Monroe Cox.

Gail O'Bryan, Deputy Clerk, County Attorney Bill Corbin and Sheriff William G. Smith were present and acting. The meeting was called to order by Sheriff Smith followed with prayer by Chairman Varnum.

A bid was received from J. C. Griffin Co., Inc., Cottondale, Florida, for furnishing and installation of four picnic tables, two 10' x 18' picnic sheds, topping and stripping for existing concrete tennis courts for the Kinard Recreation Park. The bid was opened by Attorney Bill Corbin and was as follows:

3. Furnish and install topping (color green), and stripping for existing concrete

TOTAL BID ----\$4,959.00

A motion was made by Commissioner Shiver, seconded by Commissioner Whitfield and duly carried to drop the topping and stripping on the existing tennis courts as J. C. Griffin Co., Inc. would not warrant tennis court material against any peeling or cracking that might appear after job is complete, but to accept the four (4) picnic tables and two (2) picnic sheds pending approval of the county attorney.

Mr. David Yoder met with the Board and advised that he now owns Eldridge Septic Tank business in Calhoun County, and requested he be considered for a portion of the HUD jobs. Mr. Yoder stated he is licensed in Calhoun County and is also a resident of this county.

The Board agreed for HUD jobs to be split between David Yoder Septic Tank Company and J. O. Stone Septic Tank Company, both of Calhoun County.

Mr. James A. Eubanks d/b/a Eubanks Construction, Slocomb, Alabama, met with the Board to request a Letter of Competency as a general building contractor so that he might build homes in Calhoun County.

A motion was made by Commissioner Bowman, seconded by Commissioner Cox and duly carried to issue a Letter of Competency as a general building contractor to Jim Eubanks.

The Board requested Attorney Bill Corbin to write Baxter Asphalt a letter giving them 10 days to repair the core holes made by them on Highway 274.

Commissioner Cox requested Robert Nations of Florida Engineering and Gene McClellan, HUD Coordinator, to meet with him to check over the specifications on the HUD portion of the Wrennie Moody Road.

Mr. Fernwood Bailey, County Road Superintendent, met with the Board to discuss annual leave for county employees. The Board advised all county employees would follow the Board policy for annual leave.

Commissioner Bowman brought before the Board the possibility of naming the area from Ten Mile Creek to Shelton's Trucking Company "Glory Community". Commissioner Bowman will meet with County Attorney Bill Corbin to discuss the legality of naming the community.

Commissioner Cox instructed County Attorney Bill Corbin to write a letter to M. G. Holley, Roy Pickron, Howard Johnson and Frank Guilford regarding the 45 ft. right-of-way on Jackson Street and advising them to petition the Board of County Commission and the City Council to abandon the road.

A motion was made by Commissioner Bowman, seconded by Commissioner Shiver and duly carried to adopt a resolution appointing Clerk Willie D. Wise to serve on the committee to implement state payment of fees for private attorneys appointed as special public defenders in cases where the public defender's office has certified conflict of interest. Commissioner Whitfield requested Attorney Corbin to check the lease on the sanitary landfill between Calhoun County and St. Joe Paper Company.
