BOARD OF COUNTY COMMISSION MINUTES OF JULY 20, 1982

The Board of County Commission met this day in regular session with the following members present, to-wit: Bobby Varnum, Chairman, Donnell Whitfield, Jack Bowman, Monroe Cox and Clayton Shiver.

Willie D. Wise, Clerk, Sheriff William G. Smith and Attorney Bill Corbin were present and acting. The meeting was called to order by Sheriff Smith followed with prayer by Commissioner Whitfield.

Ms. Mafalda Gray and Mr. Roy Grissett with the Department of Revenue, Mrs. Vonnie Duke, Tax Collector, and Mr. Frank Stone, Property Apppraiser, met with the Board to discuss going on line for computer services. Commissioner Bowman asked if this was mandatory with the Department of Revenue. Mr. Grissett stated it was not. After some discussion, the Board agreed to go along with Mr. Stone's recommendations as it would be hard to get the taxroll printed.

Mr. Henry Holley, Veterans Service Officer, met with the Board concerning the complaint about him not being in his office. Mr. Holley stated that he was there on Mondays and Fridays of each week.

Mr. John Hayes met with the Board to see if the air conditioner at the Calhoun County Health Department could be left on each Thursday. After some discussion, the Board agreed for it to be left on.

A motion was made by Commissioner Cox, seconded by Commissioner Whitfield and duly carried to fund the Community Services Trust Fund thru CAP as last year for \$455.00.

Mr.Logan Barbee, Director of the County Extension office, met with the Board about a copying machine for his office. The Board agreed it would save the taxpayers money in the long run since ASCS would pay for one-half of it.

Mr. Jim Doyal, Certified Public Accountant, met with the Board to explain an IBM Data Computer. A motion was made by Commissioner Whitfield, seconded by Commissioner Shiver and duly carried to take the IBM Contract.

Commissioner Whitfield requested the Clerk to order a new sign for Clemmie Road. Commissioner Whitfield stated he was personally putting up a \$25.00 reward for the arrest and conviction of the person responsible for the removal, theft or destruction of the Clemmie Road sign.

A motion was made by Commissioner Bowman, seconded by Commissioner Shiver and duly carried to tentatively adopt the budget for the Fiscal Year 1982-83. The millage was reduced from 10 mills to 9.50 mills.

A motion was made by Commissioner Bowman, seconded by Commissioner Cox and duly carried to adopt the Calhoun County Florida Housing Policy.
