

BOARD OF COUNTY COMMISSION
MINUTES OF MAY 15, 1984

The Board of County Commission met this date in regular session with the following members present, to-wit: Drew Peacock, Chairman, Roy Bailey, Donnell Whitfield, Jack Bowman and Monroe Cox.

Clerk Willie D. Wise, Attorney David House and Sheriff William G. Smith were present and acting. The meeting was called to order by Sheriff Smith and followed with prayer by Commissioner Cox.

The minutes of the meeting held May 1, 1984, were read and approved.

Commissioner Whitfield reported that Fernando Kent and Darryl Taylor were appointed and had accepted the appointment to the Planning Commission. Commissioner Cox appointed Janice Guilford and E. G. Hutchison to the Planning Commission. Commissioner Bailey stated he had appointed Ronnie Williams to the Commission.

Chairman Peacock stated one bid was received for a lawn tractor as advertised. Said bid was from Bryant's Grocery and Saw Company.

A motion was made by Commissioner Whitfield, seconded by Commissioner Bailey and duly carried to accept the low bid from Bryant's Grocery and Saw Company for a 16 HP Snapper Lawn Tractor, Model LT16001 with twin bag grass catcher for \$2,300.00. Motion carried 5-0.

Bids were opened as advertised for county insurance and are as follows

A motion was made by Commissioner Whitfield, seconded by Commissioner Bowman and duly carried to accept the low bid from Eubanks Insurance of \$27,651.00.

A motion was made by Commissioner Whitfield, seconded by Commissioner Bowman and duly carried to accept the low bid of \$14,058.00 from Midyette-Moore Insurance.

Virgil Q. Mayo, Public Defender, met with the Board requesting office space from the Board of County Commission. After some discussion, the Board agreed to work with Mr. Mayo on obtaining office space in the courthouse.

A motion was made by Commissioner Bailey, seconded by Commissioner Whitfield and duly carried to accept the low bid of \$24,014.00 from Midyette-Moore Insurance, including liability, on all county roads.

A motion was made by Commissioner Whitfield, seconded by Commissioner Bailey and duly carried to abandon the road thru Martin Sewell's property as advertised. County Attorney David House is to draw up the necessary paper work.

Mr. Tommy Williams met with the Board to discuss the legislation needed to remove the Dead Lakes Dam.

A motion was made by Commissioner Bailey, seconded by Commissioner Whitfield and duly carried to accept the letter in principle as presented by Mr. Williams.

Mr. Glen Griffin met with the Board requesting that he be considered if and when any grassing jobs are let.

Mr. Bob King, Bay Engineering, met with the Board to discuss the project cost of the HUD paving.

Commissioner Bowman reported the Jaycees were going to have a street dance in the Piggly Wiggly parking lot Saturday night, May 19, 1984, and would like to borrow 2 sets of bleachers from the S. B. Atkins Park. The Board agreed to loan 2 sets of bleachers to the Jaycees.

Commissioner Bowman reported Sheltons Park had been vandalized again, and he recommended a fence be put around the park and the gate be locked at night.

Georgia Pitts was present at the Board meeting and posed many questions to the Board and Gene McClellan, HUD Director, regarding the HUD Advisory Committee's criteria for determining rehab on houses. After much discussion between Mrs. Pitts and Mr. McClellan, Commissioner Bowman recommended that the Advisory Committee, Georgia Pitts and Gene McClellan be at a special meeting on June 12, 1984, at 5:00 PM CST in order to answer




