

BOARD OF COUNTY COMMISSION
MINUTES OF SPECIAL SESSION
AUGUST 28, 1984

The Board of County Commission met this date in special session for the purpose of opening bids as advertised for garbage service for Calhoun County with the following members present, to-wit: Drew Peacock, Chairman, Jack Bowman, Donnell Whitfield, Monroe Cox and Roy Bailey.

Deputy Clerk Gail O'Bryan was present and acting. The meeting was called to order by Chairman Peacock.

Clerk Wise stated the bids for garbage service were legally advertised. A bid was received from M & O Sanitation for \$3,000.00 per month on a 3 year contract.

A motion was made by Commissioner Cox, seconded by Commissioner Bowman and duly carried to accept the bid from M & O Sanitation for \$3,000.00 per month for 3 years subject to the approval of the provisions by the county attorney and Mr. Osborne with M & O Sanitation. Motion Carried 4-0. Commissioner Bailey voted "no".

Commissioner Bailey questioned the Board's decision to advertise for garbage service instead of the county running the garbage service.



Clerk Wise was present and acting. The meeting was called to order by Chairman Peacock.


The Board and Clerk Wise reviewed the proposed budget.


