Board of County Commissioners Minutes of Meeting

February 19, 1985

The Board of County Commissioners met this date in regular session with the following members present to: wit: Chairman Emmanuel Hires, Commissioner Ronald Wood, Drew Peacock, Roy Bailey, and Charles Richards.

Deputy Clerk Gail O'Bryan, Sheriff Buddy Smith, and County Attorney David House were present and acting.

The meeting was called to order by Sheriff Smith and followed with prayer by Commissioner Peacock and pledge of allegiance to the flag.

The minutes of February 5, 1985 were read and approved as read.

Vanetta Anderson was present at the Board Meeting to discuss coordinated transportation for the elderly, handicapped, and disadvantaged.

A motion was made by Commissioner Peacock, seconded by Commissioner Wood, and duly carried to designate the Calhoun County Senior Citizens Association as administration for the Transportation Disadvantaged and for the Board and Planning Council to work with the senior citizens on the package.

Commissioner Wood stated the Department of Environmental Regulations Hearing site, with reference to the permit for the removal of the Dead Lakes Dam, had been changed to Blountstown. He recommended the Board petition to intervene in this hearing.

Colonel Elefson of the Chipola Basin Group requested the Board of County Commissioners petition to intervene in support of the Department of Environmental Regulations in their issuing the permit to remove the dam at Dead Lakes.

A motion by Commissioner Bailey, seconded by Commissioner Peacock, and duly carried to petition to intervene in support of the State Department of Environmental Regulation in their issuing the permit to remove the dam at Dead Lakes and for the County Attorney David House to investigate and expediate the filing of the petition.

Mr. Brad Loar, with the Federal Emergency Management Agency, made a presentation regarding a detailed flood study of Calhoun County. He stated after this study homeowners would be able to purchase flood insurance.

The Board agreed to appoint Lorene Brown to the Technical Review Committee for the Apalachee Regional Planning Council.

Chairman Hires presented a letter from Sheriff Smith requesting the Board to provide funds to correct the deficiencies and violations in the Calhoun County Jail, as stated by the Department of Corrections.

The Board agreed for Sheriff Smith to obtain specifications from the Fire Marshall, and the Department of Corrections in order for contractors to ascertain the cost for correcting the deficiencies and violations at the Calhoun County Jail.

A motion was made by Commissioner Bailey, to re-district the County by population. Commissioner Bailey recinded his motion until further study is done.

A motion was made by Commissioner Peacock, seconded by Commissioner Richards, and duly carried to adjourn.

BOARD OF COUNTY COMMISSIONERS MINUTES OF MEETING

MARCH 5, 1985

The Board of County Commissioners met this date in regular session with the following members present to: wit: Chairman Emmanuel Hires, Commissioners Ronald Wood, Drew Peacock, Roy Bailey, and Charles Richards.

Clerk Willie D. Wise, Deputy Clerk Gail O'Bryan, County Attorney David House, and Sheriff William G. "Buddy" Smith were present and acting.

The meeting was called to order by Sheriff Smith and followed with a prayer by Commissioner Peacock, and pledge of allegiance to the flag.

The minutes of the Board of County Commissioners Meeting of February 19, 1985 were read.

A motion was made by Commissioner Peacock, seconded by Commissioner Bailey and duly carried to accept the minutes of February 19, 1985 as read.

Mr. Alvin Roberts, of the Court House Maintenance, presented the Board with proposals for cabinets work to be done at the County Health Department from Gable Cabinet Shop of \$1,436.00; Hires Boat and Cabinet of \$1,325.00; Billy J. Johnson of \$1,200.00, and Strawn and Son Variety Shop of \$2,030.50.

A motion was made by Commissioner Bailey, seconded by Commissioner Peacock, and duly carried to accept the low bid of \$1,200.00 from Billy J. Johnson, with the stipulation the delivery date be no more than fourteen (14) days from March 6, 1985. If Mr. Johnson could not meet this delivery date, then the next low bid from Hires Boat and Cabinet Shop, in the amount of \$1,325.00 be taken, with the same stipulation.
