TO DISCUSS COMPREHENSIVE PLAN

THE PURPOSE OF THE SPECIAL MEETING WAS TO DISCUSS THE SECOND PHASE OF THE COMPREHENSIVE PLAN.

CALL TO ORDER

THE MEETING WAS CALLED TO ORDER BY CHAIRMAN WOOD, FOLLOWED WITH PRAYER BY COMMISSIONER HIRES AND PLEDGE OF ALLEGIANCE TO THE FLAG.

MEMBERS OF THE PLANNING COMMISSION PRESENT MR. BUD CLARK AND MR. TONY ARRANT, WITH CLARK, ROUMELIS AND ASSOCIATES WERE PRESENT AT THE MEETING. MR. LESS ROBERTSON, MRS. ANNIE BAKER, MR. JOE TUCKER, AND MR. EARL BRIGHT, ALL MEMBERS OF THE PLANNING COMMISSION WERE ALSO PRESENT.

ALTHA DISCUSSED

THE BOARD QUESTIONED THE POSSIBILITY OF THE CITY OF ALTHA JOINING CALHOUN COUNTY IN THIS COMPREHENSIVE PLAN.

CITY OF ALTHA DISCUSSED

TONY ARRANT STATED THE CITY OF ALTHA WOULD HAVE 2 FUNDING CYCLES IN ORDER TO ADOPT THEIR COMPREHENSIVE PLAN AND DID NOT FEEL IT WOULD BE ADVANTAGIOUS TO THE CITY OF ALTHA TO BE INCLUDED IN THE COUNTY PLAN.

1976 PLAN DISCUSSED FOR POSSIBLE UPDATE AND USEAGE MR. ROBERSON QUESTIONED WHY THE PLAN WORKED ON PREVIOUSLY, AND COMPLETED IN 1976 BY THE PLANNING COMMISSION AND THE PLANNING COUNCIL, COULD NOT BE UPDATED AND USED.

MR. CLARK RECOMMENDED THE BOARD SUBMIT A NEW PLAN

MR. CLARK STATED THE ISSUES ADDRESSED IN THE OLD PLAN WAS NOT THE SAME CRITERIA AS THE NEW LAW AND WOULD RECOMMENDED THAT THE BOARD SUBMIT A NEW PLAN ADHERING TO THE NEW CRITERIA.

MOTION TO ACCEPT PHASE I OF THE COMPREHENSIVE PLAN AFTER MUCH DISCUSSION, A MOTION WAS MADE BY COMMISSIONER RICHARDS, SECONDED BY COMMISSIONER HIRES, AND DULY CARRIED TO ACCEPT PHASE I OF THE COMPREHENSIVE PLAN, AS
