A MOTION WAS MADE BY COMMISSIONER DILLARD, SECONDED BY COMMISSIONER HIRES, AND DULY CARRIED TO GIVE THE BOARD OF COUNTY COMMISSIONERS' EMPLOYEEES, DECEMBER 24, AND DECEMBER 25TH, 1986, OFF WITH PAY, THE SAME PERSONEL WILL ALSO BE OFF ON DECEMBER 26, 1986, WITH THE OPTION OF TAKING AN ANNUAL LEAVE DAY, OR WORKING NEW YEARS DAY, AS A MAKE UP DAY.

DR. PALMER WAS PRESENT AT THE BOARD MEETING TO DISCUSS THE CALHOUN HOSPITAL, INC.

A MOTION WAS MADE BY COMMISSIONER HIRES, SECONDED BY COMMISSIONER DILLARD, AND DULY CARRIED TO PLACE I SECURITY LIGHT AT SOUTH EAST CORNER OF THE CANNING CENTER AND I SECURITY LIGHT AT THE SOUTH END OF THE ROAD DEPARTMENT YARD. INSTALLATION AND RECURRING CHARGES ON THESE LIGHTS SHOULD BE CHARGED TO THE CANNING CENTER AND THE ROAD DEPARTMENT.

A MOTION WAS MADE BY COMMISSIONER HIRES, SECONDED BY COMMISSIONER GRANT, AND DULY CARRIED TO ADJOURN. AS THERE WAS NO FURTHER BUSINESS TO COME BEFORE THIS BODY, THEY DID THEN ADJOURN.
