THE MEETING WAS CALLED TO ORDER BY COMMISSIONER DILLARD.

CLERK WISE PRESENTED BIDS AS FOLLOWS ON THE OGLESBY ROAD PAVING, ALTHA STREET PAVING AND GRASSING AND MULCHING OF OGLESBY ROAD.

AFTER A REVIEW OF THE BIDS, IT WAS DETERMINED WHITE CONSTRUCTION WAS LOW BIDDER ON PAVING PROJECTS AND GRIFFIN CONSTRUCTION WAS LOW BIDDER ON GRASSING, SEEDING, AND MULCHING.

COMMISSIONER DILLARD ASKED THE REPRESENTIVE FROM WHITE FROM WHITE CONSTRUCTION IF HIS FIRM WAS AGREEABLE TO A VARIABLE ON THE ALTHA STREET RESURFACING AND NEW CONSTRUCTION. MR. TIMOTHY JONES REPRESENTATIVE FROM WHITE CONSTRUCTION STATED HIS FIRM WAS AGREEABLE TO A VARIABLE. COMMISSIONER DILLARD QUESTIONED MR. JONES AS TO WHEN HIS COMPANY COULD START THE PROJECT. MR. JONES STATED HE COULD BEGIN TOMORROW. THE BOARD DISCUSSED THE POSSIBILITY OF WHITE CONSTRUCTION PAVING FOR THE SAME PRICE QUOTED IN THEIR BID THE COUNTY RIGHT OF WAY IN FRONT OF THE TRAVELERS REST CHURCH. MR. JONES STATED HE WOULD HAVE TO LOOK OT OVER BEFORE COMMITTING TO THE PRICE.
