NATHAN GOODMAN PRESENTED A LETTER TO DEPARTMENT OF HRS JOSEPH KENNEDY RE: PREFERENCE OF JOB VACANCIES TO LOCAL PERSONS THE MEETING WAS CALLED TO ORDER BY DEPUTY STONE AND FOLLOWED WITH PRAYER BY REV. REA MANGUM AND PLEDGE OF ALLEGIANCE TO THE FLAG.

MOTION BY COMMISSIONER RICHARDS, SECONDED BY COMMISSIONER HIRES TO APPROVE THE MINUTES OF APRIL 5, 1988 AS WRITTEN. MOTION CARRIED 4-1. COMMISSIONER DILLARD VOTING NO DUE TO MINUTES NOT BEING READ IN PUBLIC MEETING.

REV. REA MANGUM WAS PRESENT AT THE BOARD MEETING TO GIVE A STATUS REPORT ON THE FEMA (FOOD & SHELTER GRANT). HE REPORTED 5 FAMILIES HAVE NOW BEEN HELPED. FOUR(4) FOR FOOD AND 1 FOR ENERGY. REV. MANGUM THANKED THE BOARD FOR BEING CUSTODIAN OF THE FEMA GRANT FUNDS.

COLONEL AND AUDREY ELOFSON WERE PRESENT AT THE MEETING TO REQUEST THE BOARD TO DRAFT AND ADOPT A RESOLUTION OPPOSING DREDGING IN THE APALACHICOLA BAY.

AFTER DISCUSSION, MOTION BY COMMISSIONER HIRES, SECONDED BY COMMISSIONER RICHARDS AND DULY CARRIED TO DEVELOP, APPROVE AND ADOPT A RESOLUTION SUPPORTING THE RESOLUTIONS ADOPTED BY FRANKLIN, GULF, DIXIE, SUWANEE, WAKULLA AND LEON COUNTIES OPPOSING DREDGING FOR OYSTERS IN THE APALACHICOLA BAY.
