THE MEETING WAS CALLED TO ORDER BY SHERIFF SMITH AND FOLLOWED WITH PRAYER AND PLEDGE OF ALLEGIANCE TO THE FLAG.

THE BOARD DISCUSSED THE FOLLOWING CUTS TO THE PROPOSED BUDGET.

\$1,500 PEST CONTROL	\$31,000 FINE & FORFEITURE
5,000 ATTORNEY FEES	4,946 UTILITIES

DISCUSSION ENSUED AS TO VIABILITY OF A TAX ON ELECTRICITY IN ORDER TO ENSURE AMBULANCE AND FIRE PROTECTION.

THE CHAIRMAN POLLED THE B.C.C. WITH A UNANIMOUS DECISION 3-0 (COMMISSIONER MELVIN HAVING LEFT THE MEETING) THAT THE BUDGET CUTS BE SHOWN AS ABOVE WITH THE CLERK TO DRAW UP THE PAPERWORK NECESSARY TO PASS A ELECTRIC AND PHONE TAX IN THE AMOUNT OF 10% FOR THE USE OF THE AMBULANCE SERVICE AND FIRE DEPARTMENTS.

THE BOARD REQUESTED THE CLERK TO BUDGET \$150,000 REVENUE IN ANTICIPATION AND FOR IT TO BE BUDGETED INTO THE LAND INTEREST AND PAYMENT ACCOUNT.
THE \$150,000 BUDGETED REVENUE WILL BE UNDER ORDINANCE 91-2.

CHAIRMAN WHITFIELD APPOINTED TRUMAN GRANT, PACK BOWDEN AND HIMSELF TO THE PROPERTY APPRAISAL ADJUSTMENT BOARD AND SCHEDULED THE DATE OF THE HEARING FOR SEPTEMBER 24, 1991 AT 9:00 A.M. THE CHAIRMAN REQUESTED THE CLERK TO NOTIFY THE SCHOOL BOARD SO THEY CAN APPOINT THEIR MEMBERS AND ALSO TO REQUEST THAT THE SCHOOL BOARD ATTORNEY BE PRESENT AS LEGAL COUNSEL.

THERE BEING NO FURTHER BUSINESS, THE BOARD DID ADJOURN.
