BOB CAMBRIC, APALACHEE REGIONAL PLANNING COUNCIL GAVE THE BOARD AN UPDATE ON THE FLORIDA AQUACULTURE PROCESSOR'S COOPERATIVE. MR. CAMBRIC REPORTED THAT THE FAPC BOARD HAD VOTED AT THEIR MARCH 5, 1994 MEETING TO CEASE OPERATIONS.

THE BOARD WOULD LIKE TO HOLD A JOINT MEETING WITH REPRESENTATIVES FROM ARPC ON THIS MATTER.

MS. SHARON GASKIN OF NORTH FLORIDA HEADSTART ADDRESSED THE BOARD EXPLAINING THIS PROGRAM THAT IS GETTING STARTED IN CALHOUN COUNTY AND ASKED THE BOARD FOR THEIR SUPPORT AND ENDORSEMENT.

DOWLING PARRISH PRESENTED THE BOARD THE HOUSING INCENTIVE PLAN FOR THE SHIP PROGRAM FOR BOARD APPROVAL.

COMMISSIONER WHITFIELD MADE THE MOTION TO ADOPT THE HOUSING INCENTIVE PLAN FOR THE SHIP PROGRAM, SECONDED BY COMMISSIONER CAPPS AND CARRIED 5-0.

MR. ALEX HICKS, ADMINISTRATOR CALHOUN COUNTY PUBLIC HEALTH UNIT ADDRESSED THE BOARD REQUESTING THE BOARD'S PASSING OF A RESOLUTION FOR THE WIC PROGRAM, PROCLAIMING MAY 27, 1994 AS WOMEN, INFANT AND CHILDREN'S DAY.

ADVISE OR REPRESENT THE BCC ON THE MCRAE ROAD CLOSURE DUE TO CONFLICT OF INTEREST. MR. FUQUA ALSO WILL NOT REPRESENT OR ADVISE MR. MCRAE ON THIS MATTER.

THE ANTIDISPLACEMENT & RELOCATION POLICY WAS PRESENTED FOR APPROVAL. COMMISSIONER CAPPS MADE THE MOTION, SECONDED BY COMMISSIONER WHITFIELD TO ADOPT THE ANTIDISPLACEMENT & RELOCATION POLICY AS PRESENTED. MOTION CARRIED 5-0.

DISCUSSION WAS HELD CONCERNING THE FACT THAT THE CIVIL DEFENSE OFFICE IS IN NEED OF ADDITIONAL SPACE.
