DEPUTY VICKERY CALLED THE MEETING TO ORDER. COMMISSIONER WHITFIELD LED IN PRAYER AND PLEDGE.

COACH CARLTON SMITH ADDRESSED THE BOARD REQUESTING FUNDS FOR THE CAPITAL AREA COMMUNITY ACTION AGENCY WHEN THE BUDGET FOR FISCAL YEAR 1994/95 IS DRAWN UP.

THE BOARD INSTRUCTED COACH SMITH TO SUBMIT A BUDGET REQUEST FORM FOR CONSIDERATION IN THE BUDGET FOR FISCAL YEAR 1994/95.

SILAS GREENE, JR., VETERANS SERVICE OFFICER, ADDRESSED THE BOARD REGARDING A RESOLUTION ESTABLISHING CALHOUN COUNTY AS A WORLD WAR II COMMEMORATIVE COMMUNITY.
