SHERIFF SMITH CALLED THE SPECIAL MEETING TO ORDER. THIS MEETING WAS HELD TO DISCUSS THE RESPONSIBILITY OF PROVIDING INSURANCE ON THE AMBULANCES.

MRS. BROCK INFORMED THE BOARD THAT THE COUNTY WAS NOT INVOLVED IN ACQUIRING THE GRANT THAT WAS USED TO PURCHASE THE AMBULANCES, THEREFORE THE TITLES CAN NOT BE TRANSFERRED TO THE COUNTY. CALHOUN-LIBERTY HOSPITAL ASSOCIATION WILL BE RESPONSIBLE FOR PROVIDING INSURANCE ON THE AMBULANCES.

DON A. "SONNY" O'BRYAN ADDRESSED THE BOARD REGARDING LOCATIONS FOR CLASS III GARBAGE DUMPSTERS TO BE UTILIZED BY CITIZENS DISPOSING OF DEBRIS CAUSED BY THE FLOODING OF THEIR RESIDENCES. THERE WILL BE THREE LOCATIONS SET UP FOR THESE DUMPSTERS.

COMMISSIONER BOWDEN MADE THE MOTION TO ADOPT A RESOLUTION WITH RIGHT OF WAY ENTRY FOR PRIVATELY OWNED PROPERTY TO ALLOW THE OFFICE OF FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) TO CONSTRUCT A MOBILE HOME PARK FOR TEMPORARY HOUSING FOR FLOOD VICTIMS, SECONDED BY COMMISSIONER ATTAWAY. MOTION CARRIED 3-0.

COMMISSIONER BOWDEN MADE THE MOTION TO ADOPT A RESOLUTION WITH RIGHT OF WAY ENTRY FOR COUNTY OWNED PROPERTY TO ALLOW THE OFFICE OF FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) TO CONSTRUCT A MOBILE HOME PARK FOR TEMPORARY HOUSING FOR FLOOD VICTIMS. MOTION SECONDED BY COMMISSIONER ATTAWAY AND CARRIED 3-0.
