CALHOUN COUNTY BOARD OF COMMISSIONERS REGULAR MEETING OCTOBER 4, 1994

PRESENT & ACTING:

WILLIE T. GRANT, CHAIRMAN FRED ATTAWAY DONNELL WHITFIELD PACK BOWDEN

BRENDA TODD, DEPUTY CLERK MATTHEW FUQUA, COUNTY ATTORNEY

COUNTY ATTORNEY MATTHEW FUQUA CALLED THE MEETING TO ORDER. COMMISSIONER WHITFIELD LED IN PRAYER AND PLEDGE OF ALLEGIANCE.

ALVIN ROBERTS, MAINTENANCE SUPERVISOR, ADDRESSED THE BOARD REGARDING THE SENIOR CITIZENS ROOF REQUESTING AUTHORIZATION TO ALLOW THE SENIOR CITIZENS TO PURCHASE TRUSSES FOR THE COUNTY'S ROOF TO BE REIMBURSED BY THE COUNTY FOR THE TRUSSES.

THE RESPONDED THAT BY BOARD POLICY, THIS MATERIAL WOULD NEED TO BE BID.

MR. ROBERTS AND MARILYN RUSSELL WILL MEET WITH THE CONTRACTOR ON THE SPECIFICATIONS ON THE TRUSSES, THEN MEET WITH THE CLERK TO ARRANGE ADVERTISEMENTS FOR BIDS.

MOTION MADE BY COMMISSIONER WHITFIELD FOR MR. ROBERTS AND MRS. RUSSELL TO MEET WITH THE CLERK TO ADVERTISE FOR TRUSSES AND METAL FOR THE COUNTY'S PART OF THE SENIOR CITIZENS BUILDING, SECONDED BY COMMISSIONER ATTAWAY. MOTION CARRIED 4-0.

MR. ROBERTS REPORTED TO THE BOARD THAT THE DRYER IS OUT ON THE COURTHOUSE AIR CONDITIONER AND IS REQUESTING AUTHORIZATION TO ADVERTISE FOR A NEW DRYER.

COMMISSIONER BOWDEN MADE THE MOTION TO AUTHORIZE MR. ROBERTS TO ADVERTISE FOR THE AIR CONDITIONER DRYER, SECONDED BY COMMISSIONER WHITFIELD AND CARRIED 4-0.

MR. JAMES PARKER ADDRESSED THE BOARD REGARDING PROPERTY HE HAD PURCHASED 4 MILES EAST OF THE COUNTY LINE. MR. PARKER IS REQUESTING THE PROPERTY BE REZONED RESIDENTIAL TO ALLOW HIM TO PROCEED WITH HIS PLANS TO PUT A TRAILER PARK ON THIS PROPERTY.

COUNTY ATTORNEY MATTHEW FUQUA REQUESTED TABLING THIS MATTER TO ALLOW HIM AMPLE TIME TO RESEARCH THE PROPER PROCEDURE TO REZONE THIS PROPERTY.

MR. JOHN LYTLE ADDRESSED THE BOARD REGARDING ARGUS SERVICE'S GARBAGE

. PICK-UP. MR. LYTLE QUESTIONED THE BOARD AS TO HOW THE BCC HANDLES THE GARBAGE THAT IS NOT PICKED UP. MR. LYTLE EXPRESSED HIS CONCERN FOR THE HEALTH AND SAFETY PROBLEMS THAT GARBAGE THAT IS NOT BEING PICKED UP MAY BE CAUSING.

MS. MARGARET BROCK CAME BEFORE THE BOARD TO DISCUSS THE AMBULANCE SERVICE. MRS. BROCK STATED SHE APPRECIATES THE DONATION OF THE AMBULANCES, BUT DOES NOT WISH TO ACCEPT THEM AS HER OWN.

COMMISSIONER WHITFIELD RESPONDED THAT THE AMBULANCES BELONG TO CALHOUN-LIBERTY HOSPITAL ASSOCIATION, INC. THEY WERE ACQUIRED BY A GRANT APPLIED FOR BY THE HOSPITAL.

COUNTY ATTORNEY MATTHEW FUQUA HELD THE SECOND READING OF THE CONTRACTORS ORDINANCE BY TITLE.

LENGTHY DISCUSSION WAS HELD WITH SEVERAL CONTRACTORS PRESENT REGARDING THIS ISSUE.

MOTION MADE BY COMMISSIONER WHITFIELD TO ADOPT THE AMENDED ORDINANCE AMENDING ORDINANCES # 75-01 AND #85-02, SECONDING BY COMMISSIONER BOWDEN. MOTION CARRIED 4-0.

COUNTY ATTORNEY FUQUA HELD THE SECOND READING OF THE PROPOSED AMENDED NOISE ORDINANCE BY TITLE.

COMMISSIONER WHITFIELD MADE THE MOTION TO ADOPT THE AMENDED ORDINANCE AS READ. MOTION DIES FOR LACK OF SECOND.

RECESS FOR SCHEDULED PUBLIC OFFICIALS CONFERENCE.

REGULAR MEETING RECONVENED.

COMMISSIONER BOWDEN MADE THE MOTION, SECONDED BY COMMISSIONER ATTAWAY TO EXTEND THE EMERGENCY RESOLUTION FOR AN ADDITIONAL SEVEN (7) DAYS. MOTION CARRIED 4-0.

MOTION MADE BY COMMISSIONER ATTAWAY TO ADOPT A RESOLUTION OPPOSING CONSTITUTIONAL AMENDMENT #3, SECONDED BY COMMISSIONER BOWDEN. MOTION CARRIED 4-0.
