DON A. "SONNY" O'BRYAN ADDRESSED THE BOARD REGARDING THE BIDS ON THE S.B. ATKINS PARK GRANT, PHASE I. MR. O'BRYAN AND THE SELECTED COMMITTEE REVIEWED THE BIDS AND MADE THE FOLLOWING RECOMMENDATIONS:

BALLFIELD LIGHTING - HUGH'S SUPPLY - \$36,746.79

WALKWAY LIGHTING - MACK ELECTRIC SUPPLY - \$16,304.24

POLES - APALACHEE POLE COMPANY - \$823.00

WALKING PATH, CONCRETE VEHICLE ACCESS, VOLLEYBALL/BADMINTON COURT, HANDBALL/RACQUETBALL COURT, LANDSCAPING AND SODDING - LANDSCAPE & IRRIGATION SERVICES - \$44,325.60
