MOTION MADE BY COMMISSIONER WHITFIELD TO AWARD LOW BID PER UNIT, PER CONTRACTOR, SECONDED BY COMMISSIONER BOWDEN. MOTION CARRIED 5-0.

SHIP BIDS WERE RECEIVED, OPENED AND READ ALOUD. THESE BIDS WERE TABLED TO ALLOW THE BUILDING INSPECTOR TO CHECK HIS RECORDS FOR MR. CASTLEBERRY'S PROOF OF INSURANCE AND WORKER'S COMP.

COUNTY ATTORNEY STATED THAT PUMPHREY'S BID COULD BE ACCEPTED CONTINGENT UPON THE BUILDING INSPECTOR VERIFYING THE WORKER'S COMP COVERAGE.

CASTLEBERRY HOMES BIDS WERE REJECTED DUE TO NOT PROVIDING PROOF OF WORKER'S COMP INSURANCE OR EXEMPTION.

DISCUSSION WAS HELD REGARDING THE DEVELOPMENT AND ORIGINATION OF THE TRI-COUNTY AGRICULTURE ADVISORY COMMITTEE.

LARRY FINCHER, OPERATING ENGINEERS UNION, ADDRESSED THE BCC TO REQUEST THE BOARD BUDGET UNION RAISES FOR THE ROAD DEPARTMENT AND MAINTENANCE

DEPARTMENT WHEN FIGURING THE NEXT FISCAL YEAR BUDGET.

COUNTY ATTORNEY MATT FUQUA RECOMMENDED TO THE BCC THAT ALL SHIP BIDS BE REJECTED AND RE-BID. WHEN RE-BID, MAKE BID NOTICE TO STATE THAT PROOF OF LIABILITY INSURANCE, WORKER'S COMP OR EXEMPTION BE PROVIDED IN EACH BID PACKAGE, REGARDLESS OF WHAT DOCUMENTS ARE ON FILE IN THE BUILDING DEPARTMENT.

MOTION BY COMMISSIONER BOWDEN TO REJECT ALL SHIP BIDS AND READVERTISE, SECONDED BY COMMISSIONER GRANT AND CARRIED 3-2. COMMISSIONERS CAPPS AND WHITFIELD VOTING AGAINST.

FIRST READING OF CALHOUN COUNTY COURTHOSE PARKING ORDINANCE HELD.

COUNTY ATTORNEY REQUESTED AUTHORIZATION BY THE BCC TO ADVERTISE SAID ORDINANCE.
