SHERIFF SMITH CALLED THE MEETING TO ORDER. COMMISSIONER WHITFIELD LED IN PRAYER AND PLEDGE OF ALLEGIANCE.

DISCUSSION WAS HELD REGARDING THE LEASE AGREEMENT WITH ST. JOE LAND AND DEVELOPMENT COMPANY ON THE CHIPOLA RIVER PARK LOCATED ON STATE HIGHWAY 20 WEST. COUNTY ATTORNEY FUQUA RECOMMENDED THE BOARD NOT SIGN THE LEASE WITH THE CLAUSE INDEMNIFYING ST. JOE LAND AND DEVELOPMENT COMPANY AS WRITTEN IN THE LEASE AS PRESENTED.

CLERK WISE RECOMMENDED THE BOARD SIGN THE LEASE. CHAIRMAN ATTAWAY POLLED THE BOARD AND ALL ARE IN AGREEMENT THAT THE PARK NEEDS TO REMAIN OPEN.

MOTION MADE BY COMMISSIONER WHITFIELD TO ENTER INTO THE LEASE AGREEMENT WITH ST. JOE LAND AND DEVELOPMENT COMPANY ON THE CHIPOLA RIVER PARK LOCATED ON HIGHWAY 20 WEST WITH THE LEASED PROPERTY BEING ADDED TO THE COUNTY'S INSURANCE. MOTION SECONDED BY COMMISSIONER CAPPS AND CARRIED 5-0.

CORRESPONDENCE WAS PRESENTED FROM THE DEPARTMENT OF ENVIRONMENTAL PROTECTION REGARDING THE WASTEWATER TREATMENT, PLANT.

DISCUSSION WAS HELD REGARDING THE NEED TO MAKE SURE THAT PRIDE IS MADE AWARE OF ANY AND ALL CORRESPONDENCE FROM DEP REGARDING THE WASTEWATER TREATMENT PLANT.

A LETTER FROM THE STATE ATTORNEY WAS PRESENTED REQUESTING CARPETING IN THE RECEPTION AREA OF THEIR OFFICE ON THE SECOND FLOOR AND TWO SECRETARIAL CHAIRS.

CHAIRMAN POLLED THE BOARD. THIS WILL BE CHECKED INTO AS TO THE CONDITION OF THE FLOOR IN THE STATE ATTORNEY'S OFFICE.

COMMISSIONER WHITFIELD ASKED THE COUNTY ATTORNEY TO CHECK INTO THE

COUNTY ATTORNEY FUQUA ADDRESSED THE BCC ON THE IMPASSE HEARING REGARDING THE DRUG FREE WORKPLACE.

COUNTY ATTORNEY INFORMED THE BOARD THAT PUBLIC HEARINGS NEED TO BE HELD THE FIRST AND SECOND MEETINGS IN NOVEMBER TO ADOPT THE LAND DEVELOPMENT REGULATIONS.
