Commissioner Hunt requested that the Board purchase a packer and mower for the Road Department. After discussion the Board agreed for the Clerk and Road Superintendent to prepare the specifications for a lease purchase agreement.

Commissioner Sewell discussed with the Board the trash pickup in the County.

Commissioner's Pickron and Sewell requested permission from the Board to attend a six (6) hour mandatory Ethics Class in Tallahassee. After discussion a motion was made by Commissioner Pickron, seconded by Commissioner Sewell and carried for the Commissioners to attend the class.

There being no further business, the Board did adjourn.
