# CALHOUN COUNTY BOARD OF COUNTY COMMISSIONERS MINUTES MARCH 21, 2006

#### PRESENT AND ACTING:

The meeting was called to order by Deputy Strickland, with prayer and pledge of allegiance to the flag led by Commissioner Pickron.

## BIDS

Clerk Attaway read the bids advertisement for the Small County Outreach Program (SCOP) C.R. 275 Resurfacing and Widening Project and the Board received the sealed bid as follows:

# DON A. O'BRYAN, EMERGENCY MANAGEMENT/GRANTS COORDINATOR

Mr. O'Bryan presented to the Board for approval and execution Contract Change Order #1 on the 2005 CDBG Road Paving Project from C.W. Roberts Contracting, Inc. for an 80 day time extension with a new completion date of April 18, 2006. After discussion, a motion was made by Commissioner Hunt, seconded by Commissioner Pickron and carried to approve and execute said Contract Change Order #1.

Mr. O'Bryan presented to the Board the advertisement for the invitation to bid on the design and erection of a 50'X80' Metal Pavilion at the Cooper Recreational Park. Proposals will be received by the Calhoun County Board of County Commissioners until 1:00 P.M. (CDT), Tuesday, April 4, 2006. Bids will be opened and read aloud at 2:00 P.M. (CDT), Tuesday, April 4, 2006 or as soon as possible thereafter.

Mr. O'Bryan presented to the Board the advertisement for Waste Tire Amnesty Month. The Calhoun County Board of County Commissioners has declared the month of April Waste Tire Amnesty month. During this month the residents of Calhoun County may take their waste tires to the Calhoun County Recycling Center for free and environmentally safe disposal. Waste tires will be accepted at the Calhoun County Recycling Center for only three days per week for the month of April. The hours that Waste Tires will be accepted at the Center are from 1:00 P.M.-5:00 P.M. (CDT) on Thursday and Friday and 9:00 A.M. – 1:00 P.M. (CDT) on Saturdays. Waste Tire Amnesty Month will begin on Thursday April 6, 2006 at 1:00 P.M. (CDT) and end on Saturday,

April 29, 2006 at 1:00 P.M. (CDT). The Calhoun County Recycling Center is located approximately 4 miles north of Blountstown on Magnolia Church Road/SR 71 North.
