The meeting was called to order by Deputy Hires. Prayer and pledge of allegiance to the flag was led by Commissioner McDougald.

**DON A. O'BRYAN, COUNTY ADMINISTRATOR**

Mr. O'Bryan presented to the Board for approval and execution Modification #1 to Hazard Mitigation Grant Program (HMGP) Iola Road Project for an increase in funding of \$181,558.00. After discussion, a motion was made by Commissioners Grant, seconded by Commissioner Miller and carried to approve and execute Modification #1.

Mr. O'Bryan stated that Calhoun County has been awarded \$31,934.00 federal share and \$10,644.00 local share for a total of \$42,578.00 from Federal Emergency Management Agency (FEMA) HMGP to purchase a generator for the Mossy Pond Community Center.

Mr. O'Bryan presented to the Board an update on the Large and Small Projects with Federal Emergency Management Agency (FEMA) for DR-1831 and DR-1785.

After discussion, a motion was made by Commissioner Wise, seconded by Commissioner Miller and carried to approve low bid from The County Record for 40 cents per line, per week, for three consecutive weeks.

**CLERK ATTAWAY**

Clerk Attaway discussed with the Board renewing the line-of-credit with Centennial Bank. After discussion, a motion was made by Commissioner Miller, seconded by Commissioner Grant and carried to renew the line-of-credit with Centennial Bank and for Chairman Pickron and Vice-Chairman Miller to execute the necessary paperwork.

A motion was made by Commissioner Miller, seconded by Commissioner McDougald and carried to approve the February 21, 2012 minutes as presented.

**LADDIE WILLIAMS**

Mr. Williams discussed with the Board moving a modular classroom to the Calhoun-Liberty Ministry Center. He said that the classroom is being donated to the Center. He discussed this with Mr. Arrant, County Consultant and Mr. Arrant said this could be accomplished if the plumbing was removed from the building. Mr. Williams stated that the building had to be moved off the current property by the end of the week and asked the Board to allow him to do this, and he would continue to do the necessary steps to abide with the rules in the Comp Plan.

**COMMISSIONER GRANT**

Commissioner Grant discussed with the Board the possibility of Janice Williams having a Voters Registration Drive behind the Courthouse, on County property. The Board agreed.

Commissioner Grant discussed with the Board Mosquito problems in the Hugh Creek Area.

**COMMISSIONER MCDUGALD**

Commissioner McDougald discussed with the Board accepting Victory Lane Road as a County Road. He stated that the surrounding land owners have agreed to give an easement so the road can be widened to 60'. After discussion, a motion was made by Commissioner McDougald, seconded by Commissioner Miller and carried to accept Victory Lane Road as a County Road contingent upon receiving all signed easement for surrounding landowners.
