The meeting was called to order by Deputy Hires. Prayer and pledge of allegiance to the flag was led by Commissioner McDougald.

Mr. Dan Clemons, Weatherization Coordinator informed the Board that Vision Builders had 5 Weatherization jobs and 1 Ship job from previous bids that are incomplete. Mr. Clemmons stated that there is a stipulation in the instructions to bidders that reads "Contractors with four or more incomplete Ship and/or Weatherization jobs for Calhoun County will not be allowed additional bidding until such time as existing projects have been completed." Chairman Pickron recommended to the Board, and they agreed not to accept any bids from Vision Builders.

After discussion, a motion was made by Commissioner Wise, seconded by Commissioner Miller and carried to approve the above request.

DON A. O'BRYAN, COUNTY ADMINISTRATOR

Mr. O'Bryan presented to the Board for approval and execution Contract Change Order #1 for Mossy Pond Community Center HVAC/Ceiling to North Florida Construction for an increase of \$44,309.69 for the purchase of a generator through a Hazard Mitigation Grant. Bids will be received until 2:00 p.m. (C.T.), on Tuesday, May 15, 2012, at the Calhoun County Clerk's Office, Calhoun County Courthouse, 20859 Central Avenue East, Room 130, Blountstown, Florida 32424, and will be opened and read aloud Tuesday, May 15, 2012 at 5:00 p.m. (C.T.).

Attorney Fuqua stated the Board received a Notice of Claim from Craig Yon.

CLERK ATTAWAY
