## **BUILDING OFFICIAL**


Attorney Milton advised the Board there were two candidates who applied for the Building Official position and one of those candidates withdrew their application. Attorney Milton recommended the Board authorize Joe Wood, Attorney Fuqua and Chairman Flowers to accept the applicant, negotiate the salary and offer an employment position.

A motion to authorize Joe Wood, Attorney Fuqua and Chairman Flowers to accept the applicant, negotiate the salary and offer an employment position was made by Commissioner Brown and seconded by Commissioner Jones. Chairman Flowers called for public comment. There were no comments from the public. The motion passed unanimously 5-0.

Attorney Milton advised the Board the applicant will need to work under a licensed Building Inspector while getting his license and Mr. Parrish is out temporarily. Attorney Milton stated Mr. Wood spoke with Mr. Stanley, Liberty County Building Inspector, who will oversee the applicant on an "as needed basis" during Mr. Parrish's absence or until Mr. Guilford obtains his "provisional" license. Attorney Milton recommended the Board authorize Mr. Wood to enter into an agreement with Mr. Stanley during Mr. Parrish's absence.

❖ A motion to authorize Mr. Wood to enter into an agreement with Mr. Stanley during Mr. Parrish's absence was made by Commissioner McDougald and seconded by Commissioner Brown. Chairman Flowers called for public comment. There were no comments from the public. The motion passed unanimously 5-0.

Attorney Milton advised the Board the applicant and Mr. Stanley would need to utilize the County truck to conduct the inspections. The Board agreed by consensus.



Chairman Flowers reminded the Board the Super Council meeting which was planned for Thursday, April 16, 2015 has been cancelled.

Ms. Smith, Emergency Management Director, advised the Board Mr. Parrish is the County's Flood Plain Manager and they need to consider a replacement for this position.
