The meeting was called to order by Chairman Flowers at 5:01 p.m., CT.

Prayer and pledge allegiance to the flag were led by Commissioner McDougald.


The Clerk stated this is the first of two required public hearings by the Calhoun County Board of County Commissioners for the 2015 property taxes as assessed on January 1st. The millage currently in the tentative budget is 9.90 mills and the rollback rate is 9.7021 mills. The Clerk stated the proposed millage rate is greater than the rollback rate by 2.04%. Clerk Hand stated the reasons for the proposed tax increase include: capital needs, increase in the workers compensation experience factor, Medicaid and a normal rise in costs.

The Clerk presented the Board for their approval and execution Resolution 2015-20 for an increase in Cash Carry Forward in the County Transportation Trust Fund I (CTTF I) for Fiscal Year 2015-2016 not included in the Proposed Budget. The Clerk stated the increase is for the service truck that was approved and ordered but will not be delivered until Fiscal Year 2015-2016.

A motion to accept requested salary increase for the County Probation Officer was made by Commissioner McDougald and seconded by Commissioner Jones. There was further discussion of how much the increase would be. Chairman Flowers called for public comment. There were no comments from the public. The motion passed 3-1. Commissioner Shelton opposed.

Chairman Flowers asked for public comment regarding the tentative budget and millage rate. (Requirement of TRIM Public Hearing)

The Clerk explained the Board must adopt by resolution the tentative millage and presented to the Board Resolution 2015-21:

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Calhoun County has been certified by the County Property Appraiser to the Board of County Commissioners of Calhoun County as \$405,412,497.

- 1. The FY 2015-2016 operating millage rate is 9.90 mills, which is greater than the rolled-back rate of 9.7021 mills by 2.04%.

The Clerk advised the Final Budget (TRIM) Hearing is set for September 21, 2015 at 5:01pm.


Chairman Flowers reminded the Board the Workshop regarding the Board's Personnel Policy is set for Tuesday, September 8, 2015 at 5:00pm.
