### CALHOUN COUNTY BOARD OF COUNTY COMMISSIONERS SPECIAL MEETING MINUTES AUGUST 16, 2016

**PRESENT AND ACTING:**

The meeting held in the Emergency Management Office was called to order by Chairman Brown at 2:01 p.m., CT.

#### JOE WOOD – DIRECTOR OF OPERATIONS

Mr. Wood advised the Board they will need to choose a dental plan for the County for the 2016-2017 fiscal year. Ms. Vicki Montford explained the difference between the two (2) plans. Ms. Montford stated currently employees pay a monthly premium of \$36.12 for the Ameritas dental plan pointing out employees pay 100% for dental coverage. Ms. Montford, Panhandle Insurance, provided two quotes through Ameritas. To move to an Affordable Care Act (ACA) compliant plan, the employee only monthly premium would be 38.96. The current plan (non ACA compliant) monthly premium would be \$39. Ms. Montford recommended the Board choose the ACA compliant plan. Clerk Hand stated the question the Board voiced to her was about the premium for dependent coverage. Ms. Montford stated for employee and children and employee and spouse, the ACA compliant plan would be more expensive. The ACA compliant employee and children plan would be \$6.40 more each month and the ACA compliant employee and spouse plan would be \$6.32 more each month than on the non ACA compliant plan. (Ms. Montford stated the County, a large employer, is not required to have an ACA compliant plan.) Chairman Brown asked if the benefits are better for the ACA compliant plan. Ms. Montford responded Ameritas will go with the "better benefit" of the ACA compliant plan; there are two (2) separate coverages, one for pediatric dental and one for adults, and Ameritas will always go with the better plan. In the case of the non ACA compliant plan, the adult plan is better than the pediatric dental. Commissioner McDougald asked if the choice was for the employees to decide or if the Board has to decide. Clerk Hand stated the Board must pick which plan, either ACA compliant or non ACA compliant, they wish to offer to employees; both plans cannot be offered. Clerk Hand asked Ms. Montford if the non-compliant plan was better in that case. Ms. Montford stated the non ACA compliant plan has better benefits and the employee and children rate is lower than the ACA compliant plan. The employee only, and employee and spouse coverage with the non ACA compliant plan would be four cents more expensive. Mr. Wood asked Ms. Montford if she thought the non ACA compliant plan would be the better way to go for the County employees. Ms. Montford responded the non ACA compliant plan the County participates in now would be better for those with the employee and children plan, and she will

keep the County informed of ACA rule changes. Commissioner Flowers stated he would rather go with the plan cheaper for employee and children.

 Commissioner Flowers made a motion to stay with the current non ACA compliant Ameritas Dental Plan. Chairman Brown seconded the motion. The motion passed unanimously 3-0.

Mr. Wood asked the Board to approve Resolutions 2016-19 and 2016-20 to apply for the Florida Recreation Development Assistance Program (FRDAP) Grants for the benefit of Hugh Creek Park and Mossy Pond Park, and also to add these two (2) parks to the 5 Year Capital Improvement Plan.


