Ms. Kathy Stewart stated tonight's Public Hearing is for the purpose of addressing the Final Budget amendments for the Fiscal Year 2015-2016. Florida Statutes provide the Counties 60 days after the end of the fiscal year to amend their budgets.

Ms. Stewart stated the 1st amendment is Resolution 2016-30 which will amend the budget for unanticipated revenue in the 2016 Weatherization Grant and certain Library revenues, and reallocating expenditures between line items within funds.






