Calhoun County plans to apply to Florida Commerce for a FFY 2023-2024 Small Cities Community Development Block Grant (CDBG) in the Neighborhood Revitalization category for grant funding in the amount of \$1,519,600.00. The activities, dollar amounts and estimated percentage benefit to low- and moderate-income persons are as follows:

Calhoun County is proposing four projects for CDBG funding. The first is resurfacing along with new pavement, new street signs and striping on 12th Street, 13th Street, 14th Street and Calhoun Avenue. The second project to pave and install new street signs and striping on .1 miles of Goodman Road, .1 miles of Owens Road and .5 miles on McClendon Road. The third project is for Park Improvements at Hugh Creek Park. These improvements may include new chain link fencing, lights around the walking track, exercise equipment along the trail and bleachers for the softball field. The last project is to improve the drainage system throughout the Pine Island community. Improvements will include new driveway pipes and re-grading the ditches to provide positive storm water runoff. The BOCC has already committed to providing a \$50,000 match in funding should CDBG funding be received for these projects.

Calhoun County does not expect that anyone will be displaced because of the CDBG-funded activities. If any persons are displaced because of the planned activities, the County will assist them as described in the anti-displacement and relocation policy, which is available for review at the Calhoun County Courthouse at 20816 Central Avenue E., Blountstown, FL 32424.

A public hearing to provide citizens an opportunity to comment on the application will be conducted in a handicapped accessible location at the **BOCC Board Room, 20816 Central Avenue E., Blountstown, FL 32424 on <u>April 22, 2025, at 3:30 p.m.</u> A draft copy of the application will also be available for review during normal business hours in the office of the Grants Administrator on April 21, 2025.**
